2013 LAND USE UPDATE

Co-sponsored by the Arizona Planning Association and Rocky Mountain Land Use Institute

Programs past explored the world of "zombie subdivisions" and how Arizona's local governments were coping with lots of lots and no buyers. More recently, the scarcity of infrastructure financing led one owner of an existing subdivision to sue an Arizona county for refusing to seek payment on the assurance bond posted by the original subdivider.

The first session examines subdivision assurances generally, including common types, the pros and cons of each and an alternative form of assurance used by many jurisdictions south of the Gila. The defendant county's counsel will give an update on the ongoing litigation over assurances.

Sequester or no, it's unlikely that the federal and state role in land use regulations will soon disappear. The second session draws on the expertise of the Arizona Land Department, Corps of Engineers and Arizona Department of Water Resources for an update on state assured water supply rules, and federal wetlands and endangered species regulations.

Our luncheon speaker, Patricia Salkin, dean of the Touro College Jacob D. Fuchsberg Law Center and author of the Law of the Land blog, moves ethics in land use front and center in this year's program.

In the ever-popular "Stump the Experts" section, program attendees enjoy a free-ranging question and answer opportunity with the faculty.

Return to SB 1598, the "Regulatory Bill of Rights", and explore its impacts on planning and zoning administration. Panelists will discuss how Arizona communities are implementing the law and fixes now under consideration in the Legislature.


